In FY 2016 (ending 30 June) worldwide gross revenues of PwC's network of member firms increased by 7% to US\$35.9 billion.

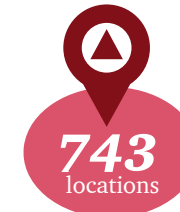
