Antônio Cássio dos Santos appointed Regional Chairman Latin America; Mike Foley to assume role of Regional Chairman North America

Mr. Senn went on to highlight the fact that the United States and Canada are key strategic areas for Zurich, and having a dedicated Regional Chairman North America reaffirms the Group's commitment to these core markets.

Antônio Cássio dos Santos joined Zurich in 2011 bringing with him 30 years of experience in the insurance industry working for national and international groups. From 2000 until 2011, he was CEO for Mapfre Brazil, leading a USD 6.5 billion Life and General Insurance business that he grew mainly organically from scratch. Mr Cássio dos Santos holds an MBA degree and completed advanced studies in Latin American Affairs at the Owen Business School at Vanderbilt University, Tennessee, USA.



Mike Foley joined Zurich in 2006 as Chief Operating Officer of its North America Commercial business unit, and in 2008 was appointed CEO of that unit. He began his career in 1989 and has held a number of roles in investment banking, insurance and consulting. During his tenure as CEO of North America Commercial, Zurich has been recognized for numerous awards, including being named in 2011 as Best Overall Commercial Insurance Provider in the National Underwriter Risk Manager Choice Awards. Mr Foley graduated in math and economics from Fairfield University, Connecticut, USA and gained an MBA in marketing and finance from the Kellogg Graduate School of Management at Northwestern University, Illinois, USA.
