## Zurich proposes three board members for re-election

Zurich, February 13, 2012 – Zurich Insurance Group Ltd (Zurich) today announced that the Board of Directors proposes the re-election of Susan Bies, Victor L. L. Chu and Rolf Watter at this year's Annual General Meeting of Shareholders on April 4, 2013. Susan Bies (U.S. citizen) is proposed for re-election for a three year term. As Rolf Watter (Swiss citizen) will reach the maximum term of office under Zurich's internal guidelines in 2014, he is proposed for re-election for a one year term.

Victor L. L. Chu (British citizen) informed the Board that he will stand for re-election for a one year term.
