Zurich plans to redevelop its global headquarters

It should blend with the existing structures populating Zurich's lakefront, an area well worth protecting. Besides structural renovation, the goal is to improve the visibility, provision of services and internal networking of the building complex and the entire area."



The new headquarters will satisfy Zurich's exacting quality standards. The project's central vision is to provide employees with an efficient and flexible workplace environment that meets current and future needs.

At the same time, Zurich is supporting the efforts of the city with regard to the 2000-Watt Society. To lend weight to this ambitious objective, the Group is seeking to gain the highest national and international sustainability standards for the new headquarters.
