

CNH Industrial completes acquisition of Miller-St. Nazianz, Inc.

The company has finalized acquisition proceedings in the United States, taking full ownership of Miller-St. Nazianz, Inc.'s assets. One of the leading American manufacturers of front boom sprayers, Miller's activities are now joined with those of CNH Industrial under the New Holland Agriculture brand, further advancing its worldwide crop production capabilities.

CNH Industrial N.V. (NYSE: CNHI / MI: CNHI) announced today that it has completed the acquisition of precision spraying equipment manufacturer Miller-St. Nazianz, Inc. ("Miller"). All assets and activities of Miller are being integrated into CNH Industrial. The Miller products will be integrated into the New Holland Agriculture portfolio, a CNH Industrial brand specializing in agricultural machinery.

Prior to this development, New Holland and Miller had a successful four-year manufacturing and distribution partnership in North America. This will further expand crop production sales utilizing the New Holland brand network, established in over 170 countries. The Miller acquisition defines a new chapter for New Holland's commitment to the professional and broad acreage segment of the agricultural industry and provides a strong platform to grow the self-propelled sprayer business on a global scale.
