**REGULATIONS CONCERNING THE PRESENTATIONS BY
THE CANDIDATES FOR THE PRESIDENCY OF THE
INTERNATIONAL OLYMPIC COMMITTEE (IOC)**

Lausanne, 30 January 2025

Preamble

The purpose of these regulations is to establish how the candidates for the election of the IOC President will present their candidature to their colleagues on the occasion of the in-person meeting organised in Lausanne on 30 January 2025.

1. General provisions

1. All the candidates will be able to present their candidature to their colleagues during the meeting organised in Lausanne at Olympic House on 30 January 2025. The candidates will not give any presentations during the 144th IOC Session.
2. The presentation by the candidates must reflect the content of their respective Candidature Document published on the IOC website.
3. All the candidates must comply with the Directives Concerning the Election of the IOC President approved by the IOC Executive Board at its meeting in Paris on 11 August 2024.

2. Organisation of the presentations

1. The candidates will deliver their presentations in the order determined by the drawing of lots by the IOC Ethics Commission during its meeting held in Lausanne on 25 November 2024. The exact times of the presentations will be communicated in due course. The IOC Director General will lead the meeting.
2. Each candidate will have 15 minutes to give their presentation and 30 additional seconds at the end of a 15-minute countdown. At the end of their time slot, the microphone will be switched off automatically.
3. There will be no Q&A sessions. There will be a short comfort break between each presentation.
4. The presentations will be given in camera and will not be broadcast or webcast on the internet. A recording will be organised for archive purposes only.
5. Only the IOC Members and the persons listed by the IOC Director General (i.e. designated IOC staff required for the technical operations) will have the right to be present in the room during the presentations by the candidates.
6. No electronic devices will be allowed in the meeting room; such devices will be collected at the entrance to the meeting room.
7. Each candidate will wait in a room reserved for each of them outside the meeting room while the other candidates deliver their presentations.

3. Presentation arrangements

1. Each candidate will speak from the lectern provided for this purpose.
2. Each candidate will speak in one of the official languages of the Session, French or/and English, as specified in Rule 23.1 of the Olympic Charter. Simultaneous interpretation in these two languages will be provided by the IOC.
3. The candidate may use the support of a PowerPoint presentation, by using the IOC template. The PowerPoint presentations will not be given to the interpreters in advance. A relay screen will be available for the candidate should a PowerPoint presentation be used.
4. Such presentation shall not include any videos, sound, photos or other images than the ones included in the IOC PowerPoint presentation template.
5. The IOC administration may not offer any assistance in the preparation, translation or finalisation of the presentations or the PowerPoint presentation.
6. On 29 January 2025, each candidate will be able to separately visit the meeting room and test the facilities (including testing the PowerPoint presentation if needed) for 10 minutes. The exact timing (between 15:00 and 17:00) for such visit will be communicated in due course.
7. No documents may be distributed at Olympic House, inside or outside the room.

4. Relations with the media

1. Outside the meeting room, a media opportunity will be organised by the IOC so that the media present in person at Olympic House can speak with the candidates. This interaction will take place after all of the presentations have been given and in the same order as the presentations. The exact timing for this media interaction will be communicated in due course.
2. No other press conference or any other formal meeting with the media shall be organised by the candidates inside or outside Olympic House. However, after the media interaction, the candidates may respond to media questions by phone or video call.
