## O HARNESS THE POWER OF SPORT

Harnessing the power of sport in our Olympic Movement is not merely about looking inward; it is about extending outward to the communities we serve, the partners we work with, and the audiences we inspire. It is a call to action for our Movement to continue leading with intention, adaptability, and purpose. By meeting the needs of athletes, enhancing the efficiency of the Olympic system, and promoting sustainable development, sport will continue to be a bridge between countries and cultures, a source of hope and a force for good.

I will remain committed to serving athletes by maintaining open dialogue and ensuring their needs are prioritized.





#### **PRIORITIZING ATHLETES**

Central to our purpose is the recognition that sport is not just a stage for performance—it is a platform for transformation. Athletes face growing pressures to represent their clubs, countries, and compete in numerous events worldwide and this requires us to create an environment where athletes are further supported and valued. Recognizing that athletes are more than competitors, we must continue to prioritize their mental health, physical recovery, and amplify their holistic well-being to help them thrive throughout their athletic careers and beyond. To achieve this, I will expand existing programs and identify new opportunities for athletes to benefit from our Olympic Partner Program (Tops), Media Rights Holders, Olympic Solidarity and further develop athlete career programs.

I am dedicated to the equality of all athletes from all countries, which also means strengthening women's sports by protecting female athletes and promoting equal opportunities for women at all levels of our Movement. As we continue breaking down inequalities, increasing inclusivity and diversity, younger generations can access the same opportunities that sport and the Olympics gave me.

Increasing visibility for our athletes and sports, during the Olympic Games and in the years between, will expand the reach of our values and positively impact the daily lives of younger generations. We already use digital tools to engage with and support athletes, but there is immense potential to scale this further by deepening our partnerships with leading Artificial Intelligence (AI) innovators, unlocking opportunities we have yet to fully explore.



Harness the expertise of our IFs to enhance the impact of every event.

#### **INTERNATIONAL FEDERATIONS**

Over the years the demands placed on our International Federations (IFs) have increased dramatically. The number of events and scale of participation have expanded significantly, creating a stressed system that impacts the ability of athletes and federations to operate effectively. Striking a balance between tradition and innovation will be key in alleviating these pressures by allowing IFs to focus on sport delivery.

Actively involving IFs is essential to creating a comprehensive Games delivery program, an ecosystem of tools and protocols that guarantees excellence and the highest standards during events. While optimization is important, it must never come at the expense of quality. Actively involving IFs means initiating a new approach by which IFs would be in a leading position when it comes to their sport at the Games. It also means that IFs would be in a better position to draw full benefit of increased revenues generated by this new approach, including the opportunities offered by the Olympic Qualifiers, the Olympic E-Sports Games and the exploitation of AI and digital engagement activities. By harnessing the expertise of our IFs, we can enhance the delivery and impact of every event.

#### NATIONAL OLYMPIC COMMITTEES & OLYMPIC SOLIDARITY

Within our Olympic Movement is a commitment to solidarity, a principle that reinforces the interconnectedness of its global community. Olympic Solidarity (OS) ensures that the Movement's resources, opportunities, and programs are equitably distributed amongst Continental Associations and National Olympic Committees (NOCs). This commitment transcends financial support; it is about nurturing an inclusive culture where every stakeholder is empowered and valued.



Reassessing our deliverables, such as the World Programs and exploring synergies between OS programs and IF development programs, we can ensure more tailored plans for each NOC. This will allow each NOC to address their specific needs and to align with their local requirements, ultimately building a much stronger and more sustainable foundation for our Movement.

Expanding the Olympic Solidarity Scholarship program for athletes, teams, and coaches, particularly in underrepresented regions, will expand our reach and grow a more diverse group of participants. This initiative will help more countries achieve diploma and medal success, enriching the Games with greater diversity. Increased diversity will attract new fans, engage wider audiences, and open opportunities for greater revenue. This in turn, will allow for a greater distribution of funds to all NOCs, further strengthening the Olympic Movement.

# ② MAXIMIZE COLLABORATION & ENGAGEMENT

As we enter a new era, we have the chance to develop stronger collaboration and engagement across our network. This revitalized cooperation will enhance the efficiency of the Olympic Movement ensuring our legacy creates a lasting impact.

#### **IOC MEMBERS**

We are all part of this movement because we believe in the power of sport and how it has touched and enriched our lives. Our diversity is one of our greatest strengths. To thrive, we must be an adaptive organization that draws on our varied backgrounds, regions, sports, knowledge, expertise, and experiences. By bringing our individual responsibilities and perspectives to the decision-making table, we can achieve an even greater global impact.

Improved internal communications between us will lead to better external communications where traditional media and journalists will have more access to sharing our ideas and triumphs. But this also means we may face greater criticism. We should be okay with this. My years of facing public scrutiny in the pool, in parliament and as chairperson of my various IOC portfolios, has built a confidence and strength within me to take full responsibility for all our decisions.

Through open dialogue and focused working groups, I will count on your opinion as we build a proactive and aligned organization. Our IOC Commissions will have greater influence and decision making power, where your contributions will lead to more meaningful outcomes, strengthening the impact of our movement. If elected, I pledge to bring all members together to assess the current state of the Olympic Movement and collaboratively define the objectives for the short, medium, and long term, guided by the vision outlined in my Manifesto.



#### **OLYMPIC MOVEMENT**

The Olympic Movement thrives on the strength of its global community and stakeholders working together toward our shared vision.

A change in leadership naturally brings a shift in dynamics, opening new doors for progress and improvement. As Minister of Youth, Sport, Art and Recreation, we prioritized defining the roles and responsibilities of the 6,000 staff members. This effort led to clearer policies, improved efficiency, increased budget utilization, and enhanced our ability to deliver results. I will lead with independence and purpose, actively engaging with each of you to evaluate and refine our internal structures to stay effective and forward-thinking. Regularly reviewing our processes and policies will open opportunities for stakeholders to exercise greater autonomy while maintaining accountability. Implementing technologies to build capacity across regions and stakeholders, will increase active participation, empowerment, and improved funding allocation.

My diverse responsibilities within the IOC, including serving as an Executive Board member, Chairperson of the Athletes' Commission, Chairperson of the Dakar 2026 and Brisbane 2032 Coordination Commissions, and member of the Finance Commission, have provided me with invaluable experience working across all IOC departments and entities. These roles have also given me deep insight into IOC policies, equipping me to begin implementing these initiatives without delay.


## ③ **STRENGTHEN PARTNERSHIPS FOR MUTUAL GROWTH**

Not everyone will compete in the Olympic Games, and not everyone will attend the Olympic Games, but everyone should have the opportunity to watch and be inspired by the Olympic Games. I will advocate for a new value proposition that strengthens relationships with existing partners and attracts new ones, whilst protecting the uniqueness of the Games and our core values. By working with the innovative potential of our digital engagement projects around OBS and Olympic Channel, our top sponsors and media partners, we can implement strategies to expand the Olympic platform. This will deepen audience engagement and create more touchpoints with sponsors and partners, between the Games.



Digital platforms, AI-powered fan engagement tools, and innovative media solutions can extend the Olympic experience to audiences in regions with limited traditional coverage. Leveraging AI technology can also create immersive experiences, empowering fans to curate their own viewing experiences. By bringing the Olympic Games directly into the hands and hearts of people everywhere, the IOC can reinforce its commitment to solidarity, expand its global footprint, and create a stronger connection with younger, digitally savvy audiences.

#### **REVENUE GROWTH**

The Olympic Movement's success is deeply intertwined with the contributions of its partners. True partnership involves creating value for all parties. For sponsors, this means crafting meaningful opportunities to connect with audiences, aligning their brands with the enduring values of the Olympic Movement. For the IOC, it is about symbiotic partnerships—balancing exclusivity with inclusivity and embracing innovative sponsorship models that broaden participation without diluting impact.

The media landscape is changing rapidly, bringing both challenges and opportunities. It is impossible to see where the media landscape will be in five years but it is clear that the trend of linear television remains a key pillar of engagement. However, the rapid growth of digital platforms, streaming services, and on-demand content calls for greater adaptability. Working with media rights holders we will explore these avenues which will enable the Olympics to reach broader and more diverse audiences so the Olympic brand remains relevant and accessible in an increasingly competitive market. As we explore these exciting avenues, we will be guided by the principle that the Games must be accessible for everyone.





#### **YOUNGER AUDIENCES**

We have a unique opportunity to inspire younger audiences through the transformative power of sport. To do this effectively, we must first understand what truly resonates with them. In today's digital age, reaching young people requires embracing social media and leveraging technology to create personalized experiences that entertain and engage.

Our digital engagement department, OBS and our media partners will continue playing a critical role in maximizing our existing platforms such as Youth Olympic Games, Olympic E-Sports and the Continental Games to amplify these opportunities.

As we work towards our vision of building a better world through sport, we should continue partnering with the UN to strengthen our efforts.
